### **Accomplishments:**

*Water system* enhancements

- While we build our reserves towards anticipated reserve expenses in 2024, we have been able to:
  - o Increase the security of our water resources with a fence around water plant
  - o Get electric up to the water tank to reduce the regular freezing problem during the winter months, and to provide a power pedestal for security of water tank hill.
  - o *Access to lots 8, 12 and 13* in Elk Meadows are complete.

*And we may now only need 30%* for a quorum but everyone's participation remains vital in light of this new Covid-19 world requiring us to not have a physical meeting as we've been doing for 45 years!
